## Q&A About Using Legal Services

### Q: Why are legal services needed?

**Answer:** Attorneys are needed in various cases, including:

- If the member is married and/or has children but does not have a will
- When buying a home
- When contemplating divorce
- When dealing with child custody issues
- When confronted with overwhelming debt
- To review any lease or rental agreement

### Q: What is excluded or not eligible under the plan?

**Answer:** Nothing. Since the plan is not an insurance policy, there are no pre-existing conditions, exclusions, waiting periods or usage limitations. All areas of law are eligible for the discounts; including but not limited to, simple traffic offenses to more complicated custody, criminal and civil suits.

### Q: Can members change attorneys, for whatever reason?

**Answer:** Simply call the toll-free number shown on your member portal, app or freshbenies card for a new referral to a participating attorney anytime.

### Q: What happens if a member moves to another part of the country?

**Answer:** Just call the toll-free number shown on your member portal, app or freshbenies card and you'll be assigned to another network attorney. With a network of thousands of attorneys in all 50 States, Puerto Rico & the U.S. Virgin Islands, members will always have their legal needs taken care of.

### Q: Are family members eligible to receive these services?

**Answer:** This benefit may be used by members, their spouse or domestic partner, dependent children under the age of 25 and any dependent individuals residing in the member's household such as a parent or grandparent.
